MOBILE/PREMANUFACTURED HOME UNIT SITE:
 A. When installing a site service in a park, the permit application must include the application fee, service, plus the number of park sites.
 B. When setting a pre-manufactured home on private property, a permit must include the application fee, service, feeder, and any new circuits.

GENERAL: Electrical work shall not begin until the application for permit has been filed with and approved by the City of Mount Clemens Community Development Department. All installations shall be conformance with the State Electrical Code. No work shall be concealed until it has been inspected.
PERMIT FEES ARE DOUBLE IF WORK HAS STARTED WITHOUT A PERMIT

EXPIRATION OF PERMIT: A permit is valid for an initial 6 months unless otherwise stated. To extend a permit contact the Community Development Department **BEFORE** the expiration date. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work. **CANCELLED PERMITS CANNOT BE REFUNDED OR REINSTATED.**
